

Philadelphia Department of Public Health (PDPH) WEEKLY MONKEYPOX UPDATE

LATEST NUMBERS

- As of September 19, 2022:
 - 446 total Monkeypox cases (confirmed + presumed)
 - Information on criteria for presumed cases available [here](#).
 - 5,795 doses have been administered.
 - Information on the federal management of Monkeypox vaccine delivery available [here](#).
- Data on Monkeypox cases and vaccine distribution, with demographic characteristics, are updated [here](#) every Monday.
- The Health Department, as part of its goal to be as transparent as possible, is one of the first jurisdictions in the country to report demographics on both people who have monkeypox and vaccine recipients.

 - When you fill out the Monkeypox Vaccine Interest Form online, PDPH will determine if you are eligible to receive the vaccine.
 - Now, you can fill out this form OR call the Health Department at 215-685-5488, you do not have to do both.
 - People who are eligible will be contacted by email or phone, to set up an appointment.
 - Appointments will be set to ensure that vaccine is given out in the most equitable manner.
 - If you don't immediately get an appointment, your name will be added to a list to be invited in the future when more vaccine appointments are available, or you become eligible.
 - The [MPX Vaccine Interest Form](#) is available in English and Spanish.
 - People who do not want to, or cannot, complete it online, or people who need assistance in other languages can call 215-685-5488 and a Health Department call taker will complete it with you.

- **Reach out and connect**

- Reach out to friends and contacts to get the emotional and logistical support you need to deal with this virus.
- Visit www.healthymindsphilly.org, for ideas, screenings, trainings, resources, and more to support your well-being while dealing with this virus.

- **Call the PDPH Center at 215-685-5488 for any possible or known exposure to Monkeypox**

- The call center will ask questions to determine risk of exposure and eligibility to be vaccinated.
- The call center can make appointments for eligible residents to get a Monkeypox vaccine and provide guidance on quarantine, isolation, and safety following exposure.

- **FREE Lyft rides**

- You can schedule a free Lyft ride to and from any Monkeypox vaccine appointment in the City of Philadelphia, by calling 215-685-5488.

- **Current CDC advice**

- Getting vaccinated as soon as possible after exposure to someone with monkeypox (ideally within 4 days) for the best chance to prevent the disease or make it less severe.
- The CDC is not encouraging vaccination against monkeypox for the broader public or for everyone who is sexually active.
 - While vaccine supplies are limited, getting a monkeypox vaccine when you don't need it could mean that people who do need it can't get it.

- PDPH is continuing to build partnerships with locations and organizations to try and offer the vaccine in more convenient locations in North and West Philly, in addition to Center City.
- PDPH continues to invite individuals to get vaccinated from our databases that may be high risk, and targeted zip codes and demographics following our case trends, as well as individuals who have been identified as high risk through contact tracing.
- PDPH staff have been going door to door to reach relevant businesses, share critical information, and hear community concerns. This effort is being scaled up to include relevant community events.

- PDPH has secured funding to compensate partners for their work to help slow the spread of this outbreak.
 - Applications closed on September 14th and are being reviewed.
