AMBULATORY/OUTPATIENT HIV MEDICAL CARE SERVICES REQUEST FOR PROPOSALS

The AIDS Activities Coordinating Office (AACO), a Unit under the Division of Disease Control within the Philadelphia Department of Public Health, is seeking applications from HIV experienced non-profit agencies in the 9-county Philadelphia eligible metropolitan area, to deliver Ambulatory/Outpatient HIV Medical Care for Persons Living with HIV/AIDS. Applicants should attend a technical assistance conference to be held on March 28, 2008 at 1pm at 1101 Market Street,11th floor. Applicants must submit a Letter of Intent no later than April 2, 2008. The Application Deadline is no later than 12:00 o'clock Noon, Monday, April 21, 2008. Late or incomplete proposals will not be accepted. Eligible applicants are non-profit organizations that are currently funded by AACO for this service with satisfactory past performance or new organizations who serve a significant number of HIV patients and have demonstrated HIV expertise as defined in the RFP.

Late or incomplete proposals will not be accepted. Eligible applicants are non-profit organizations currently funded by AACO for Medical Case Management with satisfactory past performance, or new organizations who serve a significant number of HIV clients and have providers with demonstrated HIV expertise in Case management.
